1. International Geosciences and Geoparks Programme Project Proposal Call

UNESCO is the only United Nations organization with a mandate in the geosciences through its International Geoscience and Geoparks Programme (IGGP) and in particular its International Geoscience Programme (IGCP), which is designed to support research and capacity building in the geosciences.

Since 1972, in partnership with the International Union of Geological Sciences (IUGS), IGCP has brought together many Earth scientists from around the world, including young scientists, to work on collaborative projects under the umbrella of UNESCO. IGCP has supported over 300 projects in 150 countries.

Submissions to the current call for proposals must reach UNESCO by 15 October 2018 in order to be considered for funding by the IGCP Council from 2019 onwards. Projects must focus on high-quality science, be of international importance and societal relevance, show interdisciplinary cooperation, and foster international participation, including the participation of scientists from developing countries.

2. ICS Awards nomination call

To emphasize the key role of stratigraphy in the geological sciences, the International Commission on Stratigraphy awards two ICS Prizes to outstanding geoscientists every four years during an International Geological Congress. These include the Digby McLaren Medal (awarded to honor a significant body of internationally important contributions to stratigraphy sustained over a number of



years) and the ICS Medal (awarded to honor high-quality research in stratigraphy by recognizing a single major achievement in advancing stratigraphical knowledge). The 2018 nomination deadline is 1 November and the next medal presentation will be at STRATI 2019 – The 3rd International Congress on Stratigraphy in Milan, Italy (2-5 July 2019). 3. September 2018 issue of “EPISODES” now available

The September issue contains a variety of research papers with a high proportion of contributions relating to Asia. There is an analysis of the geological structure of the South China Sea. Another structural paper considers the relationship of basement faults to alteration zones in part of central Iran. Two papers from Korea respectively consider sustainable management of ground water resources and flood vulnerability mapping. Finally there is a contribution on a NATO initiative on assessment of geohazards in both central Asia and the Caucasus. In addition to the research papers there is a field workshop report on the Ediacaran of an area in Mato Grosso do Sul, south west Brazil.

4. Information from IUGS Initiative on Forensic Geology

House of Lords Inquiry on Forensic Science: In the UK, the House of Lords Science and Technology Committee is conducting an inquiry into forensic science. IUGS-IFG has responded to a request to submit evidence to this inquiry. This provides an opportunity for IUGS, IFG and forensic geology to be brought to the attention of the House of Lords. It is anticipated the results of the inquiry will address many aspects of the much broader field of forensic science. From a forensic geology perspective those issues that need to be addressed include; regulation and accreditation, funding for research, training, the need for standard operating procedures and guidance, and attracting the next generation of forensic geologists. The hearing will be held in Autumn 2018 and recommendations are expected in the Spring 2019.

Forensic Geology in India: Following the appointment of Dr. Biplob Chatterjee, as the IUGS-IFG Officer for India. The first meeting on forensic geology in India will take place in

November 2018. This will establish a framework and strategy to develop forensic geology in India, and include engagement with the police, and other organisations. This will also focus on the development of a forensic geology session at the 36th International Geological Congress in India, in 2020, with themes to include for example; searches for missing persons and burials, crime scene examination, geological trace evidence, environmental forensics, mineral and mining fraud.

Locating graves in Colombia: The first 12 minutes of the video link below provides information on the use of technology in forensic investigations relating to the searches for the graves of people missing in Colombia. This features Dr. Carlos Molina, IUGS-IFG Officer for South America, and includes the use of geological mapping, satellite imagery, photogrammetry and geophysics.

5. IUGS President Cheng Qiuming attended the 15th Quadrennial IAGOD Symposium and Annual Assembly of ASGMI

The 15th Quadrennial International Association on the Genesis of Ore Deposits (IAGOD) Symposium was held in the city of Salta, Argentina on August 28-31, 2018. IUGS President Prof. Cheng Qiuming attended the Symposium at the invitation of IAGOD President Prof. Eduardo Zappettini to further strengthen communication and cooperation with IAGOD, an affiliated organization of IUGS. At the Symposium, Prof. Cheng Qiuming delivered a keynote speech, which introduced the latest achievements in the research on the control influence of phase transition in lithosphere, plate motion and plate subduction slab change on the formation and distribution of porphyry copper deposits in the circum-pacific and tethys tectonic-metallogenic domain.



During the symposium Prof. Cheng attended the 24th Council Meeting of the Association of Geological and Mining Survey of Ibero-America and introduced scientific activities and

programs of IUGS at the meeting. Prof. Cheng also welcomed more Latin-American countries to join the IUGS.

The Association of Geological and Mining Survey of Ibero-America (ASGMI) was founded in 1993 and the Council of ASGMI are composed of national geological surveys directors from Latin-American countries. Through bilateral and multilateral cooperation, ASGMI aims to optimize the mechanism for geological and mining services and to contribute to the social and economic development of Latin-American countries.
